The development objective of the project is to increase equitable coverage of services for immunization against vaccine preventable diseases (VPD), including poliomyelitis, for children between 0 and 23 months in Pakistan. The project has five implementing units, Federal EPI for Federating areas and four Provincial EPI for the respective Provinces.

Federal Expanded Programme on Immunization invites the Event Management Firm for the following EPI Centre/ areas federating areas under Federal EPI NISP program to train Middle Level health Professionals of Federating Areas (AJK, FATA, GB, ICT, CDA, Federal EPI) through imparting training on (I) Mid-Level Manager (II) Training of Vaccinators (III) Data Staff Training on MIS training plan approved by the World Bank or any other intermediate trainings'/workshops/ seminars during the contract. The training will help professionals to carry out their routine operations related to routine Immunization and provide them with knowledge of international best practices for the Vaccination under National Immunization Support Project (NISP). ***Duration of the assignment will be intermediate basis for the period of Life of the project or till June 2021. Interested Event management firm should provide information indicating that they are qualified to perform the indicated services. The training aim is in line with the key objective of the NISP.***

8. Payment shall be made within 30 days after completion of 100% work against submission of Invoice and Completion Report along with supporting documents.
9. Any Bidder if found engaged in corrupt or fraudulent practices (including collusion / polling), will be declared ineligible either indefinitely or for a stated period of time.
10. **The Federal EPI Program** also reserves the right to increase, decrease, delete the number of participants /federating areas to be before the issuance of “ award letter ” to the “Lowest Evaluated Bidder”.
11. **The Federal EPI Program under NISP** reserves the right to accept or reject one or all the quotations either fully or partially without assigning any reason thereof with approval justification as per World Bank Guidelines Shopping Least Cost Selection Method.
12. Submit a financial soundness certificate and listing at least 3 Clients and Reference Letters to whom similar requirements have been provided.

Quotations must be delivered at the address and to the representative, mentioned herein below on or before 14.30 hours on 26th March 2020 and quotations will be opened on the same day by the committee at 1500 Hours. Technical and financial will be sealed separately. Total Package will be considered partial quotations would not be accepted.
